Re: Completion of Texas Indigent Defense Commission Monitoring Review

Dear Judge Garcia:

This letter is to inform you that the Texas Indigent Defense Commission (Commission) passed a motion at its August 24, 2017 meeting to close its policy monitoring review of Hidalgo County's indigent defense practices. The entire Commission and its staff congratulate the Hidalgo County Judiciary, Commissioners Court, and various other criminal justice stakeholders, including the Indigent Defense Services Department and the Public Defender Office, for their efforts toward improving the county's indigent defense practices.

Beginning in 2009, the Hidalgo County Judiciary struggled with the requirement to ensure a fair, neutral, and nondiscriminatory distribution of attorney appointments. More recently, uneven distributions of attorney appointments in juvenile cases led the Commission to request regular updates of appointment data. We are encouraged by recent data reports. In particular, from the beginning of this calendar year until early August, distributions of appointments to attorney wheels fell within the legal threshold for presuming a fair, neutral, and nondiscriminatory appointment system. We have also seen that the public defender has been regularly utilized in juvenile cases. These developments should help ensure quality representation and stabilize expected expenses.
